<u>Reason</u>: Revenue in the first six months of 2025 was 1.94 times higher than the same period in 2024 (the absolute difference: VND 6,470,149,508), while the cost of goods sold in the first six months of 2025 was only 1.37 times higher than the same period in 2024 (absolute difference: VND 2,212,649,935). Moreover, total financial expenses and general and administrative expenses in the first six months of 2024 were higher than those in the same period in 2025 by VND 406,730,430. As a result, profit after tax in the first six months of 2025 increased by 4.8 times compared to the same period in 2024.
